RE: DEMANDING THE SUM OF USD6,524,700 OR ITS EQUIVALENT IN LEONES AND USD424,106 OR ITS EQUIVALENT IN LEONES AS LOSS DIRECTLY CAUSED BY THE EX PARTE INJUNCTION DATED THE 19TH AUGUST 2020

We continue to act for Kainu Ltd a party to the action instituted by your Client Marie Momoh and 114 others and another instituted with C.C. 3/20 20 M. NO. 2 which was filed in Kono.

You obtained an injunction ex-parte Order dated the 19th August 2020 which as a result of same, our Client's creditors and suppliers both local and International became apprehensive to dealing with our Client and as a result to this day, our client has lost USD6,524,700 or its equivalent in Leones with a consequential effect on loss of royalty to the government at USD424,106 or its equivalent in Leones.

In the application for the said ex-Parte order, you filed an undertaking that you shall indemnify our Client for all losses incurred as a result of the said ex-parte injunction, if it turns out that the order ought not to have been granted.

Please note that as a result of the Ruling dated the 20th day of October, 2020 the Court found out that the Court did not have jurisdiction to even hear and determine the cause of action and all subsequent proceedings which included the Order for injunction made ex-parte dated the 19th August 2020.
